Personal Information Collection Statement

Purpose of Collection

1. 2. The personal data collected will be disposed of according to our record disposal schedule. The provision of personal data is voluntary. If you fail to provide the required information, DH may not be able to process your enrolment in the briefing and related matters.

Classes of Transferees

3. The personal data you provided are mainly for use within DH but they may also be disclosed to other Government bureaux/departments or relevant parties for the purposes mentioned in item 1 above, if required.

Access to Personal Data

4. You have the right of access and correction with respect to your personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486). Your right of access includes the right to obtain a copy of your personal data provided under item 1. A fee may be imposed for complying with such a data access request.
